### President's Report:

February 21, 2024

Fellow Shareholders:

With the new Bonfire Board of Directors in place, it is time to look to the future. Your new Board is prepared to make the needs of Bonfire our top priority, just as all the past Boards have done.

I want to remind all of us of the outstanding and selfless efforts of Bobby Wolgan in his tenure as Board President. Through his leadership, the park has been updated and improved in so many areas. We all owe Bobby a note of thanks and respect.

As your new president, I want to set a new tone with respect to the Board's relationship with the Shareholders. I sense a level of friction that borders on contempt in some corners. This is not a healthy environment to oversee a park.

I remind you all that except for Janice and Candice in the office and Joe in maintenance, we are all volunteers! Everything that is done from the Social Club to the entire Board of Directors and its functions are done on a volunteer basis. Who covers the pool at night? Who locks up the Clubhouse? Who works in the kitchen? Who plans and executes Spring Fling? Etc., etc. Volunteers!

Bonfire Shareholders have escaped paying much higher maintenance fees and possible special assessments because of a volunteer Board of Directors over the years. As the new president, I'm just beginning to see all the "behind the scenes" work that is to be done and I hope I can do the job as well as Bobby Wolgan did it!

In response to the negative remarks at the annual Shareholders' Meeting and some of the Shareholders support of those remarks, concerning the finances, maintenance fees, financial reports, spending and lack of communication, describing the Board of Directors as dictators is a disgrace! Every decision that has been made over the last five years since I've been a director, has been made by people of integrity and concern for Bonfire. If the volunteer system is not doing the job to the Shareholders' satisfaction, maybe we should look for a park manager.

The decision was made during and after Covid to limit access to the office by President Bobby Wolgan and supported by the entire Board of Directors. This allowed a level of protection for Candice and Janice from Covid and kept a vital entity of Bonfire in operation.

The office will remain under limited access procedures. Anything that you may need can be accomplished by pressing the button at the office door. I leave it to the office personnel to accomplish those requests as they see fit. They assured me they have and will continue to help residents. Bonfire depends on that office running smoothly and efficiently. Janice and Candice work diligently to perform their duties and answer outside requests. They should be shown civility and respect as any of you would want to be treated.

There are a lot of homeless people around Bonfire. Some come to the office door looking for handouts; some have been found sneaking around the park. A top priority of your President and the Board of Directors is to keep our residents and employees safe. Keeping the office door locked is safe!

Our water is monitored by General Utilities and reported to the state. Historically, we have not had issues with the water. We will look into it further; however, I drink the water and have not had any problems. You may wish to purchase water to drink.

I will be looking into the need for committees and how they will be used.

With civility, common courtesy and respect, we can be the best place Bonfire can be!

### STORAGE TIMES FOR REFRIGERATOR AND FREEZER

These short time limits for home-refrigerated foods will help keep them from spoiling or becoming dangerous to eat. The guidelines for freezer storage are for quality only. Frozen food constantly stored at 0° or below can be kept indefinitely.
